I hereby agree to waive, release and forever discharge, on behalf of myself, my heirs, executors, administrators, legal representatives, assignees and successors in interest, any and all claims for damages, rights or causes of actions which I may have, or which may hereinafter accrue against the Released Parties, including any claims arising from the Released Parties own negligence.
